The Chairman Central Procurement Committee / Cell (CPC), Ministry of National Health Services, Regulations & Coordination, Government of Pakistan invites technical and financial bids for Federal Directorate of Immunization (FDI) in separate sealed covers from Clearing & Forwarding Agents registered with Income Tax and Sales Tax Departments and on Active Payers List (APL) of FBR for contracting their services to secure release of goods including Vaccines, Syringes, Cold Chain Equipment, Vehicles and other items from the Port/Airport Authorities and the Customs Department at all the seaports and airports of Pakistan and their transportation to FDI, Islamabad or and In Country Logistics from the FDI, Islamabad to all destinations within Pakistan.

Interested eligible Agents may obtain the Bidding Documents from the FDI, Prime Minister's National Health Complex, Chak Shahzad, Park Road, Islamabad on submission of a written application along with payment of a non-refundable fee of Rs. 2000/- (two thousand rupees only). Bidding Documents will be issued up to a day before the closing date for submission of bids. A copy of the Bidding Documents will also be available for information only on the website of the Public Procurement Regulatory Authority (PPRA) i.e. <a href="https://www.ppra.org.pk.and-www.epi.gov.pk">www.ppra.org.pk.and-www.epi.gov.pk</a>.
- 3. All proposals must be accompanied by a Bid Security amounting to Pak Rupees Five Million (PKR 5,000,000/-) in an acceptable form prescribed in the Bidding Documents.
- 4. Single Stage One Envelope Bidding Procedure of Principal Method of Procurement (i.e. Open Competitive Bidding) specified in the Public Procurement Rules 2004 shall be followed for receiving and processing the bids. The amount of Bid Security in the shape of pay order/bank draft/call deposit is required to be deposited in the name of the Drawing & Disbursing Officer of the FDI, Ministry of National Health Services, Regulations & Coordination, Islamabad. Any financial proposal not accompanied by the pay order/bank draft/call deposit shall straightaway be rejected.
- 5. All the interested bidders are required to register themselves and submit their bid online at <a href="http://eprocure.gov.pk">http://eprocure.gov.pk</a>.
- 6. Moreover, the original proposals along with sealed bids should be dropped in the tender box provided for the purpose in the Committee Room of the Ministry of National Health Services, Regulations & Coordination, 3<sup>rd</sup> Floor Kohsar Block New Secretariat, Islamabad up to 1100 hours on 9<sup>th</sup> January 2024 (Tuesday). Bids received up to the stipulated time will be opened publically on the same day at 1200 noon by the Central Procurement Committee/ Cell (CPC) in the presence of the Agents or their authorized representatives, who choose to be present on the occasion.
- 6. Clearing and Forwarding Agents are requested to give their best and final prices/rates as negotiations on the prices/rates once quoted/offered are not permissible under the Rules. The competent authority reserves the right to reject all bids at any time prior to acceptance of a bid or proposal as per Rule 33 (Rejection of Bids) of PPRA Rules, 2004.
